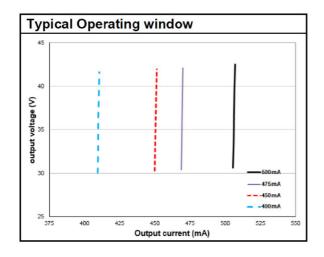

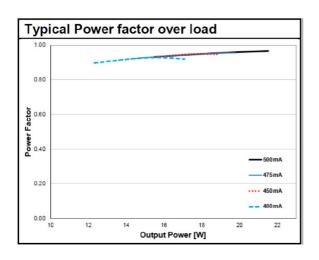

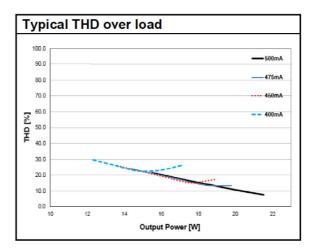




OT FIT 20220-240500 CS S MINI Operating Window

OT FIT 20220-240500 CS S MINI Typical Efficiency vs. Load (230 V  $\,$  50 Hz)

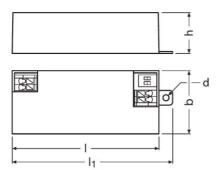




OT FIT 20220-240500 CS S MINI Typical Power Factor vs. Load
