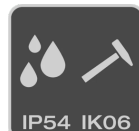

Thanks to its fold-out, robust feet, it can be quickly and easily set up next to the warning triangle. In addition, the rubberized standing feet provide non-slip stability, even in wind force 9. With an operating time of over 15 hours, the LEDguardian TRUCK FLARE Signal TA19 Essential offers long-lasting performance. The integrated test function allows you to check the battery capacity at any time. It is CE and GGVs/ADR certified²⁾, ensuring it meets the safety standards.

With an IP54 and IK06 protection rating, the LED warning light is resistant to the ingress of water and dust as well as insensitive to impacts and shocks. The package includes 4 x AA batteries, making the warning light ready for use immediately after purchase. Additionally, OSRAM provides a 2-year guarantee³⁾ on this product.
